100kg	80	21 – 42	

1. Ensure a plentiful supply of either green or dry pasture, or stubble, is available when feeding this product.
2. Place blocks on high, well-drained ground.
3. Locate blocks a minimum of 30 metres from watering points. Once stock are consuming the blocks, move them out further from watering points. This will aid in avoiding over consumption and encourage stock to graze out, utilising available paddock feed.
